

WHAT IT'S ABOUT

Labour exploitation, forced labour and human trafficking exist in Germany as well. Despite low numbers of police investigations, estimates suggest a higher number of victims of forced labour. Globally, the International Labour Organization estimates that there are 28 million victims (ILO, 2022). Forced labour occurs in various sectors such as construction, hospitality, logistics and agriculture. Victims are rarely identified as such in Germany and therefore do not receive the support and care they are entitled to by law. It is therefore crucial to build the necessary knowledge and establish effective structures for advising, supporting victims and prosecuting perpetrators.

WHO WE ARE

The Service Centre against Labour Exploitation, Forced Labour and Human Trafficking was established in 2017 by the Federal Ministry of Labour and Social Affairs based on the recommendations of the Federal-State Working Group (B-L-AG) against labour exploitation. The Service Centre is managed by Arbeit und Leben Berlin-Brandenburg DGB/VHS e.V.

WHAT WE DO

The central goal of the Service Centre is networking. It contributes to the nationwide establishment and strengthening of cooperation structures against labour exploitation, forced labour and human trafficking. It thereby enhances the competencies of relevant actors and provides knowledge and awareness of exploitative labour and forced situations at the national, regional and local levels.

The Service Centre focuses on the following:

- Surveying and documenting specific regulations and activities related to labour exploitation, forced labour and human trafficking in the federal states
- Conducting training on legal foundations, victim identification and collaboration with relevant stakeholders
- Compiling information on labour exploitation, forced labour and human trafficking in the form of an web-based information portal
- Developing and providing practical materials and specialised publications
- Promoting international exchange
